ARTICLES OF INCORPORATION OF THE GEORGIA WILDERNESS SOCIETY, INC.

ARTICLE I: NAME AND COLORS

The name of this organization shall be the Georgia Wilderness Society, Inc. The colors shall be blue, green and orange. Attached hereto is the certificate of the Secretary of State of the State of Georgia certifying the availability of the name of the corporation.

ARTICLE II: PURPOSE AND DURATION

Section 1. The corporation is organized pursuant to the provisions of the Georgia Non-Profit Corporation Code for the purpose and objective of promoting an interest in the enjoyment and preservation of wilderness areas everywhere by backpackers, canoeists and other outdoor enthusiasts. Also to do all things and undertake such programs, campaigns and related activities as may be consistent with the above-stated objectives and which are allowed by laws.

Section 2. There shall be no limitation upon corporate powers which may be conferred by Georgia law for not-for-profit corporations.

Section 3. This corporation is not organized, nor shall it be operated, for pecuniary gain or profit and it does not contemplate the distribution of gains, profits or dividends to the members thereof or to any private shareholder

The property, assets, profits, and net income of this corporation are irrevocably dedicated to charitable purpose and no part of the property, assets, profits or net income of this corporation shall ever inure to the benefit of any member or individual. Upon the dissolution, or upon abandonment, the assets of this corporation remaining after payment of or provision for all debts and liabilities of this corporation shall be donated to The Wilderness Society, Georgia Public TV, or the Macon Museum of Arts and Science or any of their successors or, if unwilling or unable to accept said donation, to such corporation or corporations, association or associations, fund or funds, or foundation or foundations having similar objectives and purposes as this corporation as the Board of Directors of this corporation may designate, subject to the order of a Court as provided by law, provided that none of such assets shall be donated to any organization other than one organized and operated exclusively for charitable purposes as presently set forth in Section 501 (c)(3) of the Internal Revenue Code.

Section 4. The corporation shall have such powers and entitlements necessary to complete its public service mission, all as set out hereinbefore and consistent with the laws made and provided.

Section 5. The corporation shall have perpetual duration, as allowed by law.

ARTICLE III: ORGANIZATION AND BYLAWS

Section 1. The initial registered office of the corporation shall be 150 Castlegate Road, Macon, Georgia 31210. The initial registered agent of the corporation shall be Charles Davis. The consent of Charles Davis to serve as registered agent is attached hereto and made a part hereof.

Section 2. The initial Board of Directors shall consist of nine (9) members who shall be:

Section 4. The corporation shall adopt bylaws not inconsistent with the provisions of these articles which have as their purpose the governance of the corporation and shall include provisions for the election of officers and Directors and the manner in which the bylaws may be amended.

ARTICLE IV: FISCAL AGENT; FISCAL YEAR

The corporation shall have the power to appoint a fiscal agent which may be a bank or trust company, and may delegate to such agent the care and management, investment and reinvestment of its funds and the maintenance of its books and records and may pay this agent compensation as agreed upon by the Board of Directors. The fisal year of the corporation shall begin on February 1st of each year and end on the last day of January of each year.

ARTICLE V: MEETINGS

Section 1. The annual meeting for the election of officers and directors shall be held in January of each year. The newly elected officers shall be installed at the next regular Georgia Wilderness Society, Inc. meeting.

Section 2. An annual banquet shall be held in December of each year and will include awards and other means of special recognition. Included will be the Gene Espy Award for outstanding achievement and the Earl Pearce Award for outstanding community service.

ARTICLE VI: MEMBERSHIP

Section 1. Membership shall be open to individuals and families who desire to promote the various corporation purposes. Members must be of good standing and approved by the Board of Directors.

Section 2. No one will be refused membership on the basis of race, creed, sex or national origin.

Section 3. Types of membership are provided by the bylaws.

ARTICLE VII: OFFICERS

Section 1. The elected officers of the corporation shall be a President, a Past President, a Vice President, a Secretary and a Treasurer, which are all elected by the members.

Section 2. The officers shall be active members who hold office for the term of one year.

Section 3. The duties of the elected officers are provided in the bylaws.

Section 4. The President may hold the office of President for no more than two consecutive one year terms.

ARTICLE V II: BOARD OF DIRECTORS; TERM; AND MEETINGS

Section 1. The control and conduct of business of the corporation shall be vested in its Board of Directors.

The Board shall include (a) the five (5) elected officers, and (b) four (4) Directors elected by the members for the term of one year. The Board shall meet at least six (6) times per year unless otherwise required to do so.

Section 2. A majority of the Board (five) shall constitute a quorum at any Board meeting.

Section 3. The Board of Directors shall transact the business of the corporation, shall fill all vacancies arising between elections, shall oversee the finances of the corporation, shall pass upon recommendations for membership presented by the Membership Committee, shall be responsible for securing and caring for the meeting location, and shall perform all duties specified by the bylaws and required by law.

ARTICLE XI: COMMITTEES

Section 1. The President, with the approval of the Board of Directors, shall appoint chairpersons of standing committees who, in turn, may select their own committee members with recommendations and suggestions from the Board, terms of office shall be for one (1) year or until their successors are appointed.

ARTICLE X: COMMITMENTS

This corporation, or its officers, shall not enter into any commitments without authorizations from a vote of a majority of the Board of Directors.

ARTICLE XI: AMENDMENTS

These Articles of Incorporation may be amended by a two-thirds vote of members in good standing at any regular meeting, but only if notice of such proposed amendments shall have been mailed to each member of the corporation at his last known address at least thirty (30) days before said regular meeting.
